Remembering Nanak Chand Rattu

Though Babasaheb Dr. B.R. Ambedkar did not born in Punjab, but in his mission, he got more support from the people of this state than any other state including Maharashtra and Madhya Pradesh (Mhow, his birth place). The names of Sohan Lal Shastri, Bimal Prasad, Kartar Singh and Nanak Chand Rattu are the prominent among his followers from Punjab, who remained with him until his last breath. Among them Nanak Chand Rattu was the most prominent. Born on February 6th, 1922, in village Sakruli of Hoshiarpur District of Punjab, Nanak Chand Rattu is best known as the most closely associated and loyal lifetimePrivate Secretary to Babasaheb Dr.Ambedkar who served him dedicatedly



for over 17 years. He was with him till late night on a day before and was the first one after Dr. Savita Ambedkar (2ndwife of Babasaheb) to notice his Mahaprinirvanon December 6th, 1956.

Nanak Chand Rattu came into the contact of Babasaheb Dr. Ambedkar after a year of his arrival in Delhi and remained in his service, first in person during his life, and after his Mahaprinirvan, in the form of writing his reminiscences and remembrances about him. Once he came into his Babasaheb's contact, he never missed a single day, including Sundays and official holidays, in his service before and after the government service duty hours. After the mortal journey of the messiah of downtrodden and the Chief architect of the Constitution of Independent India, Nanak Chand Rattu wrote a large number of books about the life and teachings of Dr. B.R. Ambedkar. Some of the most widely read among them are: Last Few Years of Dr. Ambedkar; Little Known Facets of Dr. Ambedkar; Dr. Ambedkar: Important Messages, Sayings, Wit and Wisdom; Reminiscences and Remembrances of Dr. B. R. Ambedkar; Pioneers of Ambedkar Buddhist Movement in United Kingdom.

For his untiring service to the mission of Babasaheb Dr. B.R. Ambedkar, Nanak Chand Rattu was awarded Bheem Medal, Bheem Rattan Award, Ambedkar Centenary Award, Anand Award, Ambedkar Rattan Centenary Award, Vishvrattan Dr.Ambedkar Bhushan Award and Letters of Appreciation by various national an international bodies within home and abroad. He also had embraced Buddhism with Baba Sahib. He was one of the few who accompanied the mortal remains of Babasaheb Dr. B.R. Ambedkar to Mumbai. His writings about the life and teachings of Babasaheb are a rich treasure for those who do research on Babasaheb and his mission of the annihilation of caste. His writings provided vivid description of events related with Dr. Ambedkar's life and mission. "Ambedkar Times" and "Desh Doaba" Weeklies remember him reverently on his death anniversary and pay him floral tribute.

Rising Profile of Bharat-International Day of Equality

Bharat that is India has come a long way in its 'tryst with destiny' in its journey started with Independence in August, 1947 and duly codified with the constitution of India that is Bharat in January, 1950. Every successive year saw the profile of Bharat rising not only to alleviate poverty and bring about development but also getting due space and share in the international sphere. What Dr. Ambedkar had done for the Backward Castes?

Dr. Ambedkar is often recognized as the Constituent Assembly, had inthe saviour of Dalits, while he fought for the rights of all downtrodden classes, Dalits and Backwards. But because of the Varna system, the backward castes that are Shudras consider themselves higher on the social ladder than the untouchables (Dalits). According to one definition, backward castes are Shudras, and Dalit castes are extreme Shudras. The only difference is that backward castes are considered touchable and Dalit castes are considered untouchable. It is also a

historical fact that due to being touchable, the backward castes have been exploited more than the untouchables in some areas. It is also worth mentioning that the backward castes have been caught in the clutches of fanatical Hinduism while Dalits have been continuously rebelling against Hinduism. Due to the illusion of social superiority, the backward castes have been considering Dr. Ambedkar as the leader of the Dalits instead of their own leader. This is also because most of the backward castes have been under the influence of upper caste Hindus and they have been constantly misled about Dr. Ambedkar so that they do not establish unity with the Dalits by being influ-

enced by the ideology of Dr. Ambedkar and do not create a big challenge for upper castes. Dalit and backward leaders are also responsible to a great extent for this distance between the Backward and the Dalits, who have been baking their bread by doing caste politics.

Now, if seen from the historical perspective, where Dr. Ambedkar struggled throughout his life for the rights of the downtrodden castes, he also fought continuously for the rights of the backward castes. This fact is confirmed by the following facts: -

- 1. Maharaja Sayaji Rao Gaikwad of Baroda, who belonged to a backward caste, had a great contribution in Dr. Ambedkar's higher education and he had given him a scholarship to study in America.
- 2. Chhatrapati Sahuji Maharaj was the second backward caste person who helped and contributed to Dr. Ambedkar.
- Dr. Ambedkar had very good relations with Ramaswamy Naicker, who was the leader of the non-Brahmin movement in South India.
- 4. Dr. Ambedkar was greatly influenced by the social ideology of backward caste social reformer Jyoti Rao Phule.
- 5. Dr. Ambedkar supported the movement for the equality of Ezhavas, a backward caste, in Travancore (Kerala). 6. It was Dr. Ambedkar who advocated reservation in government jobs for backward castes in the future constitution of India before the Simon Commission in 1928.
- 7. Dr. Ambedkar, as the President of

cluded the word "backward" in Article 15 (4) of the Constitution regarding reservation in government jobs, which later became a base for reservation for socially and educationally backward castes.

- 8. With the efforts of Dr. Ambedkar, a provision was made in Article 340 of the Constitution to establish a commission to identify backward castes.
- 9. The political party that Dr. Ambedkar formed in 1942 was named Scheduled Castes Federation, it was

backward classes. He reiterated the point of neglecting the interests of the backward classes in a big public meeting at Nare Park in Bombay.

12. Due to the pressure created by Dr. Ambedkar on the issue of backward castes, the Nehru government had to appoint the first Backward Classes Commission in 1951 under the chairmanship of Kaka Kalelkar. It is a different matter that the government did not accept the recommendations of this commission; rather the chairman of the commission was forced to give an



Babasaheb announced the dissolution of the Scheduled Castes Federation of India on October 15, 1956, in Nagpur and the establishment of the Republican Party of India in its place. From 1957 to 1967, based on the unity of these classes, the Republican Party of India emerged as a major political force, but later the Congress, for which this party became the biggest threat, took advantage of the weaknesses of the Dalit leaders. Bought them and this party got divided into many pieces. A party like the BSP that emerged later also destroyed this alliance.

15. In the last years of his life, Babasaheb also established contact with the leader of backward classes, Ram Manohar Lohia, etc. to establish the unity of Dalits and Backwards and there was correspondence between them. But unfortunately, Babasaheb died soon and that alliance could not be formed.

It is clear from the above description that Dr. Ambedkar not only fought for the interests of the Dalits but also for the interests of the backward classes throughout his life. It was due to his efforts that provision for reservation in government jobs for backward classes was made in the Constitution and due to the pressure created by him, the first Backward Classes Commission was constituted. Later the Mandal Commission was formed and the backward classes got reservations in government jobs and education, for which the backward classes should be indebted to Babasaheb. Therefore, the backward class should accept Babasaheb's contribution to their upliftment. There is a need to restore the unity of these classes in the context of the new challenges of the present.

is also true that there are some class contradictions between Dalits and OBCs and their unity cannot be established without resolving them. It is well known that Dalits, extremely backward (Hindus, Christians, and Muslims) are natural allies. This equation can be based on common issues and not on caste alone, which can face majority Arianism and Hindutva politics in the country.



mentioned in the policy that the party would give priority to the alliance with the parties representing the backward castes and tribes and if necessary, the party would Will change its name to "Backward Classes Federation" to represent the backward classes. Therefore, the party had also made an electoral alliance with the Socialist Party at that time.

10. In 1951, when Dr. Ambedkar resigned from the post of Law Minister regarding the Hindu Code Bill, he said, "I would like to refer to another matter which is the reason for my dissatisfaction with this government. It is about the treatment of backward castes and scheduled castes by this government. I am sad that there is no protection for backward castes in the Constitution. It has been left to the government order based on the recommendations of the commission to be appointed by the President. It has been more than a year since we passed the constitution but the government has not even thought of appointing the commission." From this you can guess how concerned Dr. Ambedkar was about the welfare of the backward classes.

11. Addressing the students of Lucknow University after resigning from the post of Law Minister, Dr. Ambedkar warned about the neglect of the backward castes and said, "If they despair in their efforts to achieve a status of equality "Scheduled Castes Federation" will give preference to the communist system and the fate of the country will sink. It can also be estimated from this how much Dr. Ambedkar was trying for the benefit of the opinion contrary to the recommendations of the commission for caste basis of reservation.

13. Dr. Chhedi Lal Sathi, who was the President of the Republican Party of India, Uttar Pradesh in the seventies, told me that Babasaheb was very disappointed after resigning from the ministerial post in 1951. At that time backward class leaders Ramlakhan-Chandapuri, S.D.Singh Chaurasia and others told him not to panic, we are all with you. For this purpose, they organized a rally of backward classes in Patna, in which a huge crowd gathered. Babasaheb was very impressed by this and again became active in the politics of Dalits and Backwards.

14. In this regard, Dr. Chhedi Lal Sathi has written in his book "Situation of Dalits and Backward Castes", on page 113 that "After coming back from Patna, Babasaheb dissolved the Scheduled Castes Federation of India in consultation with his colleagues. After losing the elections twice in 1952 and 1954, Babasaheb realized that the Scheduled Castes were only 20% of the population and so long as they did not have the support of 52% backward classes, he decided to form the Republican Party of India in its place. If he does not get it, he will not be able to win the election. Therefore; Babasaheb, in consultation with backward class leaders, especially Shivdayal Singh Chaurasia, etc., decided to include 52% backward class people and 12% population of Muslims, Christians and Sikhs in the Republican Party of India apart from 20% Dalit class. More than a year was spent in drafting

Heliports may add to disasters in Himachal Pradesh

The Himachal Pradesh Chief Minister Sukhwinder Singh Sukhu revealed during a state-level meeting that due to continuous heavy rains in the last two months, the tourism and hospitality department of the state has suffered huge losses. To compensate for these losses 16 heliports will be constructed at all the district headquaters of the state including remote tribal and far flung areas and with the construction of these heliports the target of 5 crore tourist arrivals in the state will be met annually.

The heliports will be constructed in two phases. Nine heliports will be developed in the initial phase including Jaskot in Hamirpur district, Rakkar, and Palampur in Kangra district, Sultanpur in Chamba district, Manali in Kullu district, Jispa and Sissu in Lahaul-Spiti district, and Rangrik, and Sharbo in Kinnaur district. The remaining seven heliports would be set up in the next phase, one in each district of the state, but more than one heliport will be constructed in tribal areas due to higher tourism potential in tribal areas. Construction of a heliport will greatly facilitate transportation of goods and services to tribal areas. During this meeting, he also said that the construction of heliports will create more employment opportunities for the youth of the state. Himachal Pradesh government has approved the construction of heliports in 8 districts this year and in six districts the Deputy Commissioners have already identified the land for heliports.

Development activities are very important for the development of any state. Himachal Pradesh and Uttarakhand are states nestled in the lap of the Himalayas. Being situated in the mountains, these two states are rich in natural resources. The cool clean air, springs, waterfalls and rivers, tall trees, and high hills captivate everyone. That is why the people of the plains from adjacent states mainly come for tourism in these states to get relief from the hot temperature in the summer months and enjoy snowfall in winters.

According to the Chief Minister of Himachal Pradesh, from January to the end of June this year (2023), around 1 crore 6000 thousand tourists have been recorded in Himachal Pradesh, of which 99 lakh 78 thousand were local and the rest were foreign tourists. Tourism sector is a very profitable business. That is why the Himachal Pradesh government has laid a network of roads in the last decade to get maximum benefit from this business.

Shimla, Kullu - Manali, Dharamshala, and many other cities have been connected by four-lane roads. The construction of four-lane roads has led to a rapid increase in tourist arrivals in the cities of Himachal Pradesh. With the increase in the number of tourists, multi-storied buildings, hotels, restaurants, car-parkings have been built in a rush in the cities of the state to accommodate them and park their vehicles. Looking at the economic benefit, buildings were constructed in many places ignoring the environmental regulations. The destroyed Shiva temple in Shimla



was built in the catchment area of a rain drain. The Krishna Nagar building in Shimla was also built on the Bawadi. Eight multi-storied buildings slided in Kullu were also built on the steep slope of the mountain. A slope of 25 degree is considered safe for constructing buildings in hilly areas, more slope than 25 degree is always considered as danger for buildings constructed on hill slopes. The Shukla Committee (commissioned by the Himachal Pradesh High Court), of 2010 had called for the proection of the river arguing that there is no such thing as an environment- friendly hydel project.

Similarly, a 6-km stretch of fourlane road from Kullu to Manali has been done on the bed of the Beas river and by erecting retaining walls on the flood plains and filling. This road was also washed away in this tragedy. As many as 21 tunnels have been constructed to build the Manali-Kiratpur four-lane road. These tunnels are made by blasting mountains with explosives or under-cutting mountains. Blasting of mountains with explosives weakens the mountains, causing them to lose their balance and then they try to regain their balance by sliding downward. This downward movement of mountains is known as landsliding.

While building four-lane roads, the road building companies have neglected environmental regulations. The Shimla-Parwanoo four-lane road section from Parwanoo to Dharampur has been directly cut (at 90 degree angle) at

many places. The section of this fourlane road from Parwanoo to Dharampur has been completely destroyed by landslides after the rains in the months of July and August. Nowadays, only the old two-lane road is operational in this area.

The people of Himachal Pradesh have not yet recovered from the socalled economic development in the form of four-lane roads, hydropower projects, and tourism that now a new plan of economic development through heliports has been brought. The fourlane roads built for easy access of tourists in the hilly areas have so far caused a lot of damage to the state. Now, the question arises that when the construction of four-lane roads has caused so much damage to Himachal Pradesh, then can these mountains bear the weight of heliports and helicopters? More mountains and trees will be cut and more land will be leveled to build the heliports. The balance of the mountains will further deteriorate which will increase the incidence of landslides. The Government of Himachal Pradesh is providing air connectivity to all the districts of the state to meet the target of 5 crore tourists annually. More buildings are needed to accommodate so many tourists. Where will these buildings be built? According to a report by the Geological Survey of India, there are 17,120 landslide-prone areas in the state. According to the 2003 data of the Government of India, 97.42 per cent of Himachal Pradesh's areas are prone to landslides. Will such areas withstand shocks during helicopter flights?

The mountains in which Himachal Pradesh is situated are young and continuously rising. They are very fragile and this hilly region falls in a seismically-active zone. Such a development could be very fatal for Himachal Pradesh. The Deputy Commissioner of that district is marking the areas in which the heliport is to be built. Construction in such sensitive areas is first discussed with the environment committee of that area and an environmental impact assessment is conducted there. After this, detailed information is given through print and electronic media to get the opinion of the people of that area, if they agree then the project is started and in case of no, it will be improved. The whole process repeated again.

Helicopters emit more pollutants into the environment than means of road transportation. Greenhouse gasses released by helicopters will pollute the environment and also increase

the temperature here. According to a 2020 report by the union ministry of earth sciences, India's average temperature increased by 0.7 degree Celsius during the period 1901–2018, while the

temperature of the Hindu Kush Himalayas increased by 1.3 degree Celsius during the period 1951–2014. Several areas of Hindu Kush Himalayas have experienced a declining trend in snowfall and also retreat of glaciers in recent decades. Only time will tell how much the temperature will rise with the construction of 16 heliports and the arrival of 5 crore tourists annually.


According to the fifth and sixth reports of the Intergovernmental Panel on Climate Change, India will be more affected by climate change due to temperature rise than many other countries of the world. India has snow laden mountains to the north and ocean on three sides to the south. The resulting rise in temperature will lead to rapid melting of glaciers and increasing the intensity of flash floods, cloudbursts, heavy and unseasonal snowfall and so on, while oceanic disasters in southern regions. If the Himachal Pradesh government does not change its economic development plans, the state could face more disasters.

To protect the state from natural disasters, the Government of Himachal Pradesh should first seek the opinion of environmental experts, geologists, and local people before undertaking any development project. Hilly areas cannot bear the weight of any infrastructure and population beyond their capacity.

Therefore, instead of increasing the number of tourists, the government of state should determine the number of tourists according to the bearing capacity of the cities. Instead of constructing heliports and four-lane roads, the old two-lane roads should be properly repaired and made passable.

The government should provide convenient means of public transport instead of private vehicles, helicopters. By limiting the number of private vehicles and tourists there will be no need to build multi-storied buildings and more spaces for parking. By doing this, the existence of Himachal Pradesh will also be preserved and it will also remain a center of attraction to tourists for a long time.
